THE BUSINESS ACTIVITY FOR SAID ORGANIZATION I S AS FOLLOWS: THE CORPORATION IS ORGANIZED UNDER CHAPTER 180 OF THE GENERAL LAWS OF THE COMMONWEALTH OF MASSACHUSETTS EXCLUSIVELY FOR CHARITABLE PU RPOSES, INCLUDING, FOR SUCH PURPOSES, TO PROVIDE EXPERT, FINANCIAL AND OTHER MATERIAL ASSISTANCE TO KATHMANDU INSTITUTE OF CHILD HEALTH (KIOCH), DULY RE GISTERED WITH THE GOVERNMENT OF NEPAL AND AFFILIATED WITH SOCIAL WELFARE C OUNCIL OF NEPAL, THAT WORKS FOR PROMOTION OF CHILD HEALTH THROUGH HEALTH EDUCATION, PREVENTIVE, CURATIVE AND REHABILITATIVE HEALTH CARE IN NEPAL. THE CORPORATION MAY CARRY ON ANY ACTIVITIES IN CONNECTION WITH ANY OF THE FOR EGOING PURPOSES, AND HAVE AND EXERCISE ALL OF THE PURPOSES AND POWERS CONF ERRED UPON NONPROFIT CORPORATIONS UNDER SECTION 6 OF CHAPTER 180 OF THE GE NERAL LAWS OF THE COMMONWEALTH OF MASSACHUSETTS AS NOW IN FOR OR HEREAF TER AMENDED, AND DO EVERYTHING NECESSARY OR APPROPRIATE TO ACCOMPLISH AN Y OF THE FOREGOING PURPOSES TO THE EXTENT PERMISSIBLE UNDER THE LAWS OF COM MONWEALTH OF MASSACHUSETTS, ALL TO THE EXTENT NOT INCONSISTENT WITH THE R EQUIREMENTS CONTAINED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, AS A MENDED, AND NOT INCONSISTENT WITH ANY OTHER PROVISIONS OF THESE ARTICLES O F ORGANIZATION.

NOTWITHSTANDING ANY OTHER PROVIS ION OF THIS DOCUMENT, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVIT IES NOT PERMITTED TO BE CARRIED ON (A) BY AN ORGANIZATION EXEMPT FROM FEDERA L INCOME TAX UNDER SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESP ONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (B) BY AN ORGANIZATION, CO NTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C) (2) OF THE INTERNAL R EVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. UPON THE DISSOLUTION OF THIS CORPORATION, ASSETS REMAINING SHALL BE DISTRIBU TED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDER AL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT DISPOSED OF SHALL BE DISPOSED BY THE COURT OF COMMON PLEAS OF THE COUNTY IN WHICH THE P RINCIPAL OFFICE OF THE ORGANIZATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PU RPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETER MINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
